- e. Hours of operation: 9:30 am to 3.30 pm - Sunday the 4th of October, 2026.
- f. Attendance numbers cannot be guaranteed. No refunds provided due to low attendance rates.
- g. No refunds granted should the fair be cancelled due to weather events or unforeseen circumstances.
- h. Should the fair be cancelled prior to the advertised date, all fees paid will be fully refunded to a nominated account.
- i. All vehicles must be removed from the site before 8.30 am. Please note; sites do not allow for parking or camping. (Parking available in public parking areas)
- j. All stallholders must hold current Public Liability Insurance (minimum \$10mil) and must attach a copy to this application to be considered. Food/Take Away Food stall holders must meet NSW Food Handling Regulations and hold Food Handler Safety Training Certificates - copies also need to be attached to this application.
